

EVENT AGREEMENT

THIS AGREEMENT, effective today, _____, is between _____, (The Client), and Saudades Group LLC – dba Churrascaria Saudades – Brazilian Steakhouse, (The Restaurant), for a private room event scheduled on _____.

HEAD COUNTS. The Client shall guarantee payment for a minimum of ____ guests. The Client shall provide a final headcount no later than 48 hours prior to the event, but shall not be less than the minimum guarantee stated above. A private room shall be set for the guaranteed minimum guest count. If The Client requests an additional number of table place settings be set for unexpected guests, it shall be deemed to be the new headcount establishing a new minimum guarantee.

CANCELLATION. The Restaurant requires a 48hr cancellation notification. The Client guarantees payment for the minimum guest count should a cancellation (or no-show) take place.

FEES. The Client shall pay the Restaurant \$_____ per person (plus any options selected). Included with this amount is our regular full service of endless meat and access to our gourmet salad bar (provided only on the first floor), non-alcoholic beverages (some restrictions apply), and one dessert per person from a limited dessert menu. All alcoholic or specialty beverage charges shall be charged by consumption. Meat service shall conclude at our posted closing time. It is agreed that a 20% gratuity shall be added to the final bill at the end of the evening.

APPETIZER OPTION. The Restaurant shall serve appetizers (dedicated server making rounds with tray) as guests arrive, for an additional charge of \$5 per person per appetizer selected (for example: 2 appetizer selections for \$10pp; 3 appetizer selections for \$15pp). The Client has opted for (enter quantity of 1,2, or 3) _____appetizer(s) for an additional per person cost of \$_____ **per person.**

ROOM FEE. Private room rate(s) of **\$500** (Sunday-Thursday) or **\$1,000** (Friday/Saturday) for the use of a private room.

PRIVATE ROOM. If A Private Room option is selected, The Restaurant reserves the right to host the event in the private room of its choice and at the sole discretion of The Restaurant.

DOUBLE BOOKING. The Restaurant reserves the right to book another private event in a different room at the same time.

DEPOSIT. A non-refundable deposit (credited towards the final bill) of \$250 is due at time of signing.

ALCOHOL. The Restaurant reserves the right to refuse service to any customer that appears (at the Restaurant's sole discretion) to be intoxicated.

RULES. There shall be no outside music or dancing. Separate guest checks shall not be produced. Meat service shall not begin until all guests have arrived.

FULLFILMENT. The Restaurant shall not be held liable for any loss that results from not fulfilling any terms or conditions of this Event Agreement. If the Restaurant is prevented, or delayed from fulfilling, in part or in whole, this Event Agreement due to unforeseen events, or by any other act or condition that is not within The Restaurant's control, and which could not be prevented, The Restaurant shall not be held liable.

ATTORNEY FEE(S). If either party brings a suit or other action against the other to enforce this Event Agreement or to seek damages with respect to the default of any listed obligations, the party to which favor is ruled shall be due the recovery of all costs and reasonable attorney fees.

JURISDICTION. This contract shall be governed by the laws of the State of Delaware (and any applicable Federal Laws).

ENTIRE AGREEMENT. This Agreement constitutes the entire agreement between the parties. Neither The Restaurant nor The Client have made any representation or promise, except as herein contained.

SEVERABILITY. If any portion of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.
